HOW TO LEAVE A GIFT IN YOUR WILL

Including a gift in your Will is a simple and meaningful way to show your support. You can include a specific sum, percentage of your estate, or even a residual gift after other commitments have been fulfilled.

Here's an example of the wording you might include in your Will

a) I give, devise and bequeath \$[amount] (Gift) to SYDNEY SWANS FOUNDATION CO LIMITED (ABN 80 667 843 165) of [1 Driver Avenue, Moore Park, New South Wales] (or its successor organisation) for its general purposes and I declare that the receipt of the secretary, trustee or other officer of such organisation is full and sufficient release for my trustees without seeing to the final distribution of the funds.

b) If the Gift under paragraph (a) cannot take effect completely or at all, to the extent that it cannot take effect I give, devise and bequeath the Gift to SYDNEY SWANS LIMITED (ABN 48 063 349 708) of [1 Driver Avenue, Moore Park, New South Wales] (or its successor organisation) for its general purposes and I declare that the receipt of the secretary, trustee or other officer of such organisation is full and sufficient release for my trustees without seeing to the final distribution of the funds.

We always recommend seeking professional legal advice when drafting or updating your Will.

There are several ways to include the Sydney Swans Foundation in your Will:



RESIDUAL GIFT:

After taking care of your loved ones, you can leave the remainder of your estate to the Foundation.



PERCENTAGE GIFT:

Nominate a percentage of your estate to be donated.



SPECIFIC GIFT:

Leave a specific amount or a particular asset such as property, shares, or collectibles.



WHOLE ESTATE GIFT:

In some cases, individuals choose to leave their entire estate to the Sydney Swans Foundation.
